Euclid Municipal Court

Euclid Municipal Court is a single jurisdiction Court serving the City of Euclid.

The Court is located at 555 East 222nd Street, in Euclid, Ohio.

At the direction of Administrative/Presiding Judge Patrick J. Gallagher, the 2018 Euclid Municipal Court staff included three part-time Magistrates; a Chief Probation Officer and two Probation Officers; a Clerk of Courts and three Division Chief Deputies, ten Deputy Clerks, two Bailiffs, and six part-time Court Security Officers.

Euclid Municipal Court has two Divisions:

- Civil/Small Claims Division consists of civil actions with the statutory monetary limit of \$15,000 and small claims actions with a statutory limit of \$6,000.
- Criminal/Traffic Division consists of the handling of initial appearance hearings of felony cases, criminal misdemeanor cases, and traffic citations issued by the Euclid Police Department, Ohio State Highway Patrol, Cleveland Metroparks Police Department and the Cuyahoga County Sheriff.

2019 Court Program Highlights

Community Clinics

In 2019, the Court conducted three (3) Community Clinics at the Euclid Library which focused on driving under suspension issues and expungements of criminal convictions. At the Clinics, we assembled volunteers from the Euclid Municipal Court Public Defenders, the Cuyahoga County Public Defender's Office, the CWRU Law School, the Ohio Bureau of Motor Vehicles and the Legal Aid Society to provide advice and guidance to individuals whose driving privileges were suspended and to individuals seeking to expunge criminal convictions.

At the Clinics - the BMV was able to process application for the BMV Amnesty Program and was able to grant forgiveness of more than \$30,000 in reinstatement fees for the applicants.

With our efforts to promote expungements – we have doubled the number of expungements the Court has granted. In 2017, the Court granted 67 expungements whereas in 2019, the Court granted 128 expungements.

Bond Schedule

The Court is required to establish a bond schedule which sets forth pre-determined bond amounts for persons arrested for criminal offenses. In 2019, the Court revised its bond schedule to mandate personal bonds for all offenses except felonies, domestic violence, violations of protection orders, menacing by stalking, and any sexually oriented offense. This change protects victims and the community at large while also reducing the number of persons held in custody awaiting a bond hearing.

Scheduling

In an effort to decrease the amount of time people are waiting in Court to have their cases heard, the Court changed its schedule to dedicate one day to arraignments while pretrials are scheduled on various days. The Court has also limited the number of pretrials in cases to reduce the number of times defendants, victims and witnesses are required to attend Court proceedings.

Euclid Municipal Court Probation Department

The Euclid Municipal Court Probation Department is staffed with two (2) full-time Probation Officers and a Chief Probation Officer who monitors all defendants who have been sentenced to a term of community control. Together all Officers are currently managing approximately 502 active cases with in the City of Euclid. The Probation Department is responsible for conducting investigations for Pre-Sentence Hearings, First Offender (Diversion) Referrals and Expungement request; with the growing number of unlicensed drivers we are working to help individuals to obtain a valid driver's license. The Euclid Probation Department is here to ensure that Court ordered conditions are satisfied and that the rules of probation are abided by until the term of probation has been complete.

We (the Probation Department) are working diligently to assist with the safety of the community, the rehabilitation of the offenders that are referred and or assigned to the Probation Department and improving public confidence in justice by treating everyone with procedural fairness.
