Euclid Municipal Court

Euclid Municipal Court is a single jurisdiction Court serving the City of Euclid.

The Court is located at 555 East 222nd Street, in Euclid, Ohio.

At the direction of Administrative/Presiding Judge Patrick J. Gallagher, the 2022 Euclid Municipal Court staff included one part-time Magistrate; two full-time Magistrates: a Chief Probation Officer and two Probation Officers; a Clerk of Courts and three Division Chief Deputies, nine Deputy Clerks, two Bailiffs, and six part-time Court Security Officers.

Euclid Municipal Court has two Divisions:

- Civil/Small Claims Division consists of civil actions with the statutory monetary limit of \$15,000 and small claims actions with a statutory limit of \$6,000.
- Criminal/Traffic Division consists of the handling of initial appearance hearings of felony cases, criminal misdemeanor cases, and traffic citations issued by the Euclid Police Department, Ohio State Highway Patrol, Cleveland Metroparks Police Department, Cuyahoga County Sheriff, and the Cleveland Clinic Police Department.

Euclid Municipal Court 2022 Highlights

Collaboration of Municipal Courts

We are now collaborating with various Municipal Courts in the area to provide assistance to defendants to clear open warrants. Historically, in order to clear an open warrant, a defendant would have to surrender to the local police department and either pay a bond or sit in jail until the defendant appeared in Court. Many defendants do not have funds to post a bond and most will be terminated from their employment if required to sit in jail for even one day. A process is now in place in the participating Courts whereby a defendant can appear in court without posting a bond and request that the warrant be recalled.

Towards Employment

Towards Employment is present at the Court twice per month. Each session is two (2) hours. Towards Employment provides:

- assistance in securing employment;
- assistance in securing transportation, tools, and uniforms;

- assistance to clear warrants, prevent evictions and foreclosures, address child support arrears, and clear debt;
- career planning, coaching, and skill building through work experience and technical training so newly hired workers can succeed in their current job and then advance along a career pathway.

This is not just for Euclid Municipal Court defendants. Anyone can walk-in and meet with the Towards Employment representatives. In addition, other Courts may refer defendants to the Towards Employment sessions at the Euclid Municipal Court.

Right To Counsel in Eviction Actions

We continue to cooperate with the Legal Aid Society's program to provide Right-To-Counsel to tenants in eviction actions. On a weekly basis, the Court provides the Legal Aid Society with a list of all eviction cases filed in our Court. Legal Aid then sends information to the tenants about the legal assistance program. The Court also mails with the Summons and Complaint a handbill explaining that the tenant may be eligible for free legal assistance and providing contact information for the Legal Aid Society and United Way.

For tenants, this program may stop evictions by asserting valid legal defenses, get tenants additional time to move, protect tenants' property, reduce or avoid liabilities, address unit repairs and apply for rental assistance. For landlords, this program may streamline proceedings where there is no valid legal defense, provide a negotiated resolution, protect landlords' property and facilitate payment to the landlord through tenants' rental assistance programs.

By providing access to legal counsel, this program promotes public confidence in the judiciary. This improves the litigants' perceptions of the fairness of the judicial system and thereby promotes the community's confidence in the outcomes of the judicial system.

First Offenders Program

The number of participants in the Court's First Offender Program continued to increase over the previous year. In 2022, we admitted 84 defendants to the First Offender Program. Under this Program, the defendant must be a first offender and must complete community service hours, counseling programs, undergo drug and alcohol testing and treatment (if necessary), obtain employment, and not engage in any criminal conduct. If defendant successfully completes all requirements, the charges are dismissed and defendant's record is sealed. This program has huge implications and benefits – especially for young people

Expungements

In 2022, we processed 163 requests for expungements. This represents an increase over 2021. We actively and intentionally advise and encourage Defendants to pursue expungement at the appropriate time.

Computerization

The Court has now replaced all computers. We are continuing the implementation of the Pioneer Benchmark Case Management System. Once operational, this new case management system will provide electronic filing, on-line access to imaged documents, remote access by Court personnel, calendaring, in-court processing, email and text message notification to attorneys and parties. These functions will directly impact the Court's efficiency, user-access and transparency. We expect the new case management system to go live this year.

Website

The Court received a grant from the Ohio Supreme Court of \$35,100.00 for a new Court website. We went live with the new website in May, 2022. Our website can be found at euclidmunicourt.com

Euclid Municipal Court Probation Department

The Euclid Municipal Court Probation Department is staffed with two (2) full-time Probation Officers and a Chief Probation Officer who supervises all defendants who have been sentenced to a term of community control or diversion. Together all Officers are currently managing approximately 509 active cases as of 03/28/2023. The Probation Department is responsible for conducting investigations for Pre-Sentence Hearings, First Offender (Diversion) Referrals, supervising defendants that are court ordered to complete a term of Community Control and conditions along with completing Expungement request and any additional referrals and request. The Euclid Probation Department is here to ensure that Court ordered conditions are satisfied and that the rules of probation are abided by until the term of probation is complete or terminated.

We (the Probation Department) are working diligently to assist with the safety of the community, the rehabilitation of the offenders that are referred and or assigned to the Probation Department and improving public confidence in justice by treating everyone with procedural fairness.

The Euclid Municipal Court is working to incorporate alternative sentencing recommendations such as community service, house arrest monitoring, treatment and prevention programs etc., in lieu of the traditional jail sentencing, court cost and fines to ensure that the defendants that receive any form of sentencing have the means to successfully fulfill their court obligations. During Covid the Probation Department utilized alternative appointment reporting options such as reporting by phone, email and zoom to limit the foot traffic coming in and out of the Euclid Municipal Court building for safety precautions.
